Single assessment only	€ 870.00
1-3 assessments per year	€ 1,740.00
4-10 assessments per year	€ 3,475.00
11-20 assessments per year	€ 6,085.00
Unlimited assessments per year	€ 11,575.00

Multiple year discount fee

If a 3 years TAM license is purchased, a discount of 20% is offered on the yearly fee.
